The BROWSE Project



 Its main objective is to improve the assessment of risks to operators, workers, residents and bystanders by delivering new and improved models of exposure, thus improving the basis for targeting of risk reduction policy

 First consultation with stakeholders (Brussels) 14-15 April 2011)

- Brief review of the state of the art relating training and awareness raising
- Brief overview about the SUD requirements
- Requested stakeholders opinions in on priorities, factors influencing the exposures, formats,...



Main results of the 1st BROWSE stakeholder consultation about training



 In developing training materials for professional users we should focus especially on explaining the risks for operators, workers, bystanders. Furthermore attention should be also paid on prevention and mitigation measures to minimize risks

 The training material should take into account that the activity carried out by the operator or worker/ personal conduct is seen as the main group of factor influencing exposure. On the other hand also aspects related to the working environment affecting exposure should be considered



Main results of the 1st BROWSE stakeholder consultation about training



- For the training materials addressed to operators of hand held application equipment and knapsacks (art 8), BROWSE should focus on proper spraying techniques. But also risk for human health and factors that can exacerbate risk should be taken into account
- Videos is seen as the most efficient technic in training of operators. Furthermore also paper based information material and information material distributed electronically could be adopted



Main results of the 1st BROWSE stakeholder consultation about awareness raising



- Especially Risks and potential acute and chronic effects on human health needs to be included in the BROWSE communication material for the general public.
- Especially the contact with treated areas should be addressed with most priority in the communication material
- Videos is seen as the most efficient technic to be use in the communication material

These plans will take account the stakeholder consultation regarding:
